That did not stop her from running and playing like any other young cat. And this lucky tabby cat got adopted into her forever home.



After this family adopted Sylvia, they brought 5 or 6 cats to Bond County Humane Society's annual Paws In The Park to be micro-chipped. That was a real treat. We chipped them in the van just in case they got loose. Fortunately everything went well. In January 2011 they sent this email and photo: "Hope you had a great Holiday. We adopted Sylvia back on February 25, 2006. I attached a couple photos. She is doing well and spoiled as are all our cats. Jim and Leslie Joseph."



**Sarah** and her littermates were dumped in a ditch with their mother. A kind lady stopped and brought the black and white Labrador Retriever mix puppies to BCHS. After that, all they knew was warmth and cleanliness. Sarah was very loving and liked to snuggle in people's arms. She enjoyed chasing her littermates and chewing on chew toys. When she was about 3 months old, a family adopted her from BCHS.

In April 2011 they wrote BCHS: "Hello, I wanted to say hello and send a few photos of our wonderful puppy. Our daughter elected to change her name to Midnight and she seems to like it very well. I am amazed at how smart she is, only 1 accident since she has come home.

Even our dog Sophia seems to love her; they play constantly. Each morning the 2 dogs and I go for mini walks and her training is going great. She sits, stays close, walks well on the leash and has even learned the words IN and OUT. Each time we enter the home she sits at the door waiting for me to unhook her leash. Funny thing she has learned how to bark; yes I know she has always barked. But now when we sit on the couch and I act like I am ignoring her she will bark at me. I tell her to hush and that I am the boss; she will bark again so I bark back and this interaction of us barking at each other lasts forever. LOL. ## Announcements and News

### Shelter Update – "Phase One" Construction

Since our last newsletter Shelter News update, BCHS has made more tangible and important progress towards a permanent animal shelter building in Greenville, Illinois. We've commissioned and bought engineering plans for a 5,300 square foot, steel-constructed shelter from a reputable kennel building supplies and equipment company. Taking this step provides us with a real, financial goal amount to get materials and labor pledges and to organize a building capital fund campaign. South Elm land site has a sign (well, we had a sign until the Feb. 27, 2011 wind storm) and trees. Solid figures, initial floor plans, and very recently even a culvert, a driveway and a storage building. This is real movement forward.

In May 2011, construction was completed of a 24'x48' storage building on the South Elm Street property, future site of BCHS. The purpose of the building is to house, in one location, all of the equipment previously stored in various other places. It is not a structure intended for, nor appropriate for, office space or animal boarding. The addition of this building puts the property "in use" for non-profit purposes and we have filed an application with the county to obtain tax exempt status from the state. If approved this would eliminate the annual property tax obligations on the property. The new culvert was



furnished and installed by the City of Greenville. Services to install the driveway and building excavation work were donated by Plunkett Services of Greenville.

We rely on the local community to continue its support of our goals to continue improvement of animal welfare in and around Bond County.

This is only the first step in having a new shelter complex, but it is an important one. As an organization BCHS is determined to make this happen for the benefit of local animals. We need the community's help and support to make this a reality. ### **Pet Poison Prevention Tips**

- Be aware of the plants you have in your home and yard. The ingestion of azalea, oleander, castor bean, sago palm, Easter lily (cats only), or yew plant material by an animal can be fatal.
- Never allow your pets to have access to the areas in which cleaning agents are being used or stored. Cleaning agents have a variety of properties; some may only cause mild stomach upset, but others can cause severe burns of the tongue, mouth and stomach. Store all cleaners, pesticides, and medications in a secured area.
- Most bait contains ingredients that can attract your pets. When using rat, mouse, snail or slug baits, or ant or roach traps, place the products in areas that are inaccessible to your companion animals.
- Never give your companion animals medication unless you are directed to do so by a veterinarian. Many medications that are safe for humans can be deadly for animals. For example, one extra-strength (500mg) acetaminophen tablet could be fatal to a cat.
- Keep all prescription and over-the-counter drugs out of your pets' reach, preferably in closed cabinets. Pain killers, cold medicines, anti-cancer drugs, antidepressants, vitamins and diet pills are all examples of human medications that can be lethal to animals, even in small doses.
- Food items that potentially could be dangerous to pets include onions, onion powder, chocolate (bakers, semi sweet, milk, dark), alcoholic beverages, yeast dough, coffee (grounds, beans, candy covered beans, tea, caffeine), salt, macadamia nuts, hops, tomato leaves and stems (green parts), rhubarb leaves, avocados (toxic to birds, mice, rabbits, horses, cattle, and dairy goats), cigarettes, cigars, snuff, chewing tobacco, moldy or spoiled foods.
- Many common household items can be dangerous to animals: mothballs, potpourri oils, pennies, homemade play dough, fabric softener sheets, dishwashing detergent, and batteries.
- Automotive products such as gasoline, oil and antifreeze should be stored in areas that are inaccessible to your pets. As little as one teaspoon of antifreeze can be deadly to a cat; less than one tablespoon can be lethal to a 20-pound dog.
- Before buying a flea product, consult your veterinarian, especially when treating sick, debilitated or pregnant pets.
- Read all of the information on the label before using a product on your pet or in your home. Always follow the directions.
- If a product is for use only on dogs, it should never be used on cats; if a product is for use only on cats, it should never be used on dogs. Never use permethrin spot on products (which are labeled for dogs only) on your cat.
- Make sure your companion animals do not enter areas in which insecticidal foggers or house sprays have been applied for the period of time indicated on the label.
- If you are uncertain about the proper usage of any product, contact the manufacturer and/or your veterinarian for instructions.
- Many plants can be toxic to your pets. Please keep houseplants out of reach of your pets.

If you think that your pet may have ingested a potentially poisonous substance, call your vet's emergency phone number.



## **What Happens To Your Pet If Something Happens To You?**

I have begun to notice just how intrusive the conversation regarding pet trusts is for the general public.... When I ask "Have you made arrangements for your pets if something were to happen to you?," the number one answer I get is "My kids will care for them". Thank you very much, end of conversation!

Shelters, with whom I speak more regularly, would love to show the public all of the pets they have who were supposed to be cared for by the "kids". One shelter told me a story of a daughter who called from the mother's death bed asking them to come pick up the dog she was supposed to care for. Another shelter told me the story of the son who contacted them to take the dog because it had become blind, and he didn't want to, or know how to care for, a blind dog. Every year [shelters receive quite a few] pets due to the owner's death or disability. You may say, well that is not much, but add that to the pets they receive due to financial hardship, divorce, puppy mills, and "just don't want the pet anymore", and they are drowning in our irresponsible planning.

I know it is not easy to face the fact that we are all going to die, and that many of us will become disabled, but when inviting a pet into our home planning for continued care of your pets is essential. Many of the pets who survive the owner are old and have not experienced any other home. In a shelter setting they are traumatized by the strange environment, and by missing the only person they have known for

their care. If we cannot face our own mortality then perhaps we can get concerned with the fate of our loving companions, our pets. The golden rule seems to apply here, treat your pet companion the way you would like to be treated, with respect and dignity. They did not ask to be here!

As a responsible pet owner, you provide your pet with food and water, shelter, veterinary care, and love. To ensure that your beloved pet will continue to receive this if something unexpected were to happen to you, it's critical to plan ahead.

The best way to make sure your wishes ensuring long-term or permanent care for your pet are fulfilled is by making formal arrangements that specifically cover the care of your pet. It's not enough that long ago your friend verbally promised to take in your animal or even that you've decided to leave money to your friend for that purpose. Work with an attorney to draw up a special will, trust, or other document to provide for the care and ownership of your pet as well as the money necessary to care for her.
